





Instructor: Ok. So, you want to learn about the English society and culture.


Student: To have a decent job after graduation.

You will have the chance to participate and speak in the class. You will the chance to have a say. "To have a say" means "to have an opinion" of the chance to have a say."



So, you can translate the rest of the text on your own, and I will try to see your translation.



Instructor: It depends. In translating from English to Arabic, students most of the time translate to Arabic but in an English style. So, the translated text would be Arabic words but in an English style, and that's the problem that we will try to solve through this course.

In translating, we have to transfer the message genuinely in an understandable way in both the source and the target text.

For example, we cannot translate, "It is a piece of cake to be a translator" as the following:

يقول انها قطعة حلوى لكى أكون مترجماً.

Let us take another example.

In English, they say:

- "In collaborating with (بالتعاون مع ..., taking into consideration (الأخذ بعين الاعتبار) the circumstances..., and caring for the children, the Ministry of Social Affairs and Labour ( وزارة الشؤون الاجتماعية did (so and so...)"

When we try to translate this to Arabic, we cannot say:

بالتعاون مع (كذا وكذا...) والاخذ بعين الاعتبار ظروف (كذا...) واهتماماً بالأطفال، قامت وزارة الشؤون الاجتماعية والعمل ب...

This is not correct in Arabic. We have to say first ' قامت الشؤون then we continue. Hence, the sentence can be translated as the following:

✔ قامت الشؤون الاجتماعية بالتعاون مع (كذا وكذا...) آخذة بعين الاعتبار ظروف (كذا...) واهتماماً بالأطفال ب...

This is the correct structure in Arabic.

Now, I want to talk about the idea of using Google Translate. Honestly, I am against using such an app. However, you might use it sometimes for the sake of knowing the meaning of certain words, but it is better to use an English-English dictionary. ويمكننا ايضاً استخدام غوغل لمعرفة معنى كلمة ما من خلال كتابة الكلمة وكلمة "meaninig" بجانبها.


We know that the order of the English structure is S (subject) V (verb) O (object). So, when translating from English, we have to search for the verb.







Hundreds of cash-strapped "Squid Game" fans competed in a real-life recreation of the dystopian smash-hit Netflix series for a \$456,000 cash prize.

Popular YouTuber MrBeast, who boasts 76.4 million subscribers, said he spent \$3.5 million on the elaborate reenactment in which 456 contestants battled for the jackpot.

The social media star, whose real name is Jimmy Donaldson, said on Twitter that it cost him around \$2 million to build and produce, while he spent around \$1.5 million on prizes.


In addition to the six-figure first prize, Donaldson doled out \$2,000 to every competitor and \$10,000 to the runner-up.


The recreation included the same Korean children's games played in "Squid Game," such as Red Light, Green Light, marbles and tug-of-war — in huge sets that took weeks to construct. But unlike in the unsettling drama, no contestants were harmed.

Players were instead rigged with "wireless explosives" packed with fake blood that burst open when a player was eliminated.

In the tug-of-war and glass bridge challenges, losing contestants fell into a foam pit rather than plummeting to their deaths.

But true to form, the real-life "Squid Game" contestants were seen in footage of the game trembling as they tried to carve shapes out of honeycomb in the "dalgona challenge."


Gender-based violence (GBV) is a global epidemic rooted in gender inequality. All persons are at risk of violence because of their gender or perceived gender. Women and girls experience disproportionate gender-based violence, and this violence is even more prevalent among women and girls who have been forcibly displaced.

Globally, 1 in 3 women experience violence during their lifetime. In some humanitarian emergencies, more than 70 percent of women have experienced GBV, and an estimated 1 in 5 displaced women will experience sexual violence. Due to conflict, persecution, and natural disasters, an estimated 68.5 million people have been displaced, including 25.4 million refugees, 3.1 million asylum seekers, and 40 million internally displaced persons. The catastrophic number of displaced persons, coupled with the increased risk of GBV in these settings, threatens the lives of millions of women and girls, as well as global progress toward gender equity and empowerment.

Even in the best situations, accessing justice for survivors of violence is extremely difficult. In humanitarian settings, the process is rife with obstacles. Displacement disrupts social support systems, removes connections to services and familiar legal avenues, and inserts added stress and economic insecurity, which are key drivers of violence. While violence is often perpetrated by family members, traffickers, or other displaced persons, documentation also shows abuse from national migration administrations, peacekeeping forces, and humanitarian staff, which further exacerbates the balance of power and distrust in protection systems.

In addition to fear of their abuser(s), victims of GBV also often have a general distrust of the systems designed for their protection. For displaced populations, a general mistrust of legal systems, limited courts and legal staff, and difficulty navigating legal systems can leave survivors of violence with minimal to no means of legal justice. For survivors with irregular legal or citizenship status, seeking justice through formal legal systems can be perilous, potentially resulting in detention or deportation.

Displaced communities also often create and place value on informal justice systems, where legal decisions are negotiated through community, religious, or family leaders. However, even in these informal systems, the rights and best interests of survivors are rarely upheld.



While conferences, events and in-person gatherings are still an excellent way to network, the current climate does not allow for it, making LinkedIn an easy and effective way to build connections.

When companies post positions online, LinkedIn algorithms match them to the perfect candidate. These algorithms search for various keywords (hence the importance of LinkedIn optimization, as stated before), as well as for the number of first-degree connections you have. If your profile is strong and your connections are in order, you are placed at the top of the search results for recruiters and hiring managers.
